Payment Requirements: Accommodations in each category at the group rates are limited and subject to availability. Reservations are made on a first-come, first-served basis. A deposit of **\$250 per person is required** to confirm your reservation. **The final payment is due no later than December 16, 2019.** Additional payments are accepted at anytime until final payment. Cruise payments can be made by cash, money order, check or credit card. Royal Caribbean accepts VISA, MasterCard, Discover, or American Express. Discounted group rates might not be combinable with other discounts or coupons.

Rates: Prices are based on double occupancy and include cruise rate and all taxes. Additional charges include flights, airport transfers, travel insurance and gratuities for onboard ship service personnel. Celebrity Cruises reserves the right to reinstate the fuel supplement of \$10 per person, per day.

Cancellations: MAGIC charges a \$25.00 per person administrative fee for all cancellations. In addition, Celebrity Cruises charges a cancellation fee if the cancellation occurs during a penalty period. The penalty periods and cancellation fees are as follows:

<u>Days Prior to Sailing</u>	<u>Cancellation Penalty</u>
December 17, 2019-Jan 20, 2020.....	25% per person
January 21– Feb 2, 2020.....	50% per person
Feb 3– March 3, 2020.....	75% per person
March 4, 2020 or later.....	100% per person

Celebrity Cruises Flight Arrangements

Guests wishing to add air travel to their cruise package may do so by using Celebrity's Air2Sea program. Flights should arrive into San Juan (SJU) by 6:00 PM April 4 and depart after Noon April 11. Ask MAGIC for details.

NOTE: Travel insurance offers coverage for cancellation if you have to cancel for a covered reason. Celebrity considers the day prior to the departure date as the first day. You must contact us by 5:00pm EST the day before the penalty period begins to avoid the fee OR contact Celebrity directly if over the weekend.

Travel Insurance: MAGIC recommends the purchase of travel insurance to cover yourself and your investment in the event of unforeseen circumstances. Celebrity offers Cruise Care Vacation Protection based on your cruise cost (\$59-\$299). We also offers US citizens an Allianz Horizon plan for 7.25% of your cost. Coverage must be paid for at the time of final payment. Contact MAGIC for a comprehensive listing of the included benefits.

Travel Documents/Proof of Citizenship: Based on current legislation, all U.S. and Canadian citizens must show proof of citizenship in the form of a valid passport book OR a government issued birth certificate along with a photo ID (Government issued) and supporting documentation for any name changes (i.e. Marriage Certificate). Non U.S. citizens should contact MAGIC before making a reservation. It is the responsibility of all Non U.S. citizens to check with the local immigration office, embassy, or consulate to determine documentary requirements. There is no refund if a passenger is denied boarding the ship for lack of proper documents.

Not Included: Items not part of the cruise vacation price include (but are not limited to): airfare, transfers, optional shore tours, wines/liquor/soft drinks, specialty dining options, gambling, gratuities, laundry and items of a personal nature.
